

Turnover ratio

The ratio gives an indication of how many constituents are replaced and added over a year

It is computed as

$$\text{Turnover ratio} = \frac{\max(\# \text{ of companies added in the year, } \# \text{ of companies removed in the year})}{\text{average number of companies over the year}}$$
